Instructions

The ATHENA Award Program celebrates the potential of all women as valued members and leaders of the community and recognizes those who support them. The ATHENA Award honors individuals who strive toward the highest levels of professional accomplishment ... women and men who excel in their chosen field, have devoted time and energy to their community in a meaningful way, and who also open paths so that others may follow. The committee welcomes and encourages resubmissions of any past nominations for consideration during the current year.

THE CRITERIA

ATHENA recipients must meet each of three specific criteria.

Demonstrate excellence, creativity, and initiative in their business or profession;

Provide valuable service by devoting time and energy to improve the quality of life for others in the community;

Assist women in reaching on their full leadership potential.

COMPLETING THE FORM

Nominations for the ATHENA Award must be submitted using this nomination form. Form must be typed or printed clearly.

One additional sheet may be added to this form, and a resume may be submitted. "Scrapbooks" or other separate supporting documents should not accompany the form. These materials will not be considered during the selection committee deliberations.

Please review the nomination form carefully to ensure that comprehensive, quantitative information is supplied which demonstrates the involvement, achievement, and leadership accomplishments of your nominee. The more complete the information provided, the more useful this form will be for those who judge this important award.

THE PROCESS

A Selection Committee of prominent community leaders will review all nomination forms and select the ATHENA Award recipient.

The ATHENA Award recipient will be announced during the Breakfast for Champions, December 10, 2019 at the Odawa Casino & Resort - Ovation Hall in Petoskey.

BUSINESS ACCOMPLISHMENTS:

List special recognitions, projects, and achievements. Include business-related affiliations, directorships, trusteeships or other designations.

This section should be in essay or narrative format, not a listing. Make the case for your applicant's leadership in business, excellence, creativity and initiative. This is the first of three critical criteria for this award.

Tell your applicant's story, citing their education, background, history in their chosen profession, professional success and success of business.

Tell about the awards they have received, and what business organizations, service clubs, boards, etc. that they are involved in.

This section can be three paragraphs, around 350 words.

COMMUNITY SERVICE:

Describe local, county, and state level participation, length of service and offices held in civic and service organizations, charitable activities, political pursuits, religious groups, chambers of commerce, merchants' associations, etc.

This section is also a key in the criteria - how the nominee gives back to the community.

This can be a list of all of the positions, years, length of service offices held in their support of nonprofit organizations, membership organizations, charitable activities, work with their church, chamber, service clubs. For example:

Member of Rotary International 2001-2020

Board member 2004-2008

President of board 2007-2008

Finance Committee 2005-2007

Executive Committee 2006-2008

Chamber of Commerce member - 2000-2020

Membership Committee - 2005-2007

Board - 2008-2014

Chair - 2013-2014

(List all chambers separately - i.e. Petoskey, Charlevoix, Harbor Springs, etc.)

Contributes financially to: List organizations

(And yes, service and memberships were in the narrative in section one, and that is okay to repeat here)

ASSISTS WOMEN IN REACHING THEIR FULL LEADERSHIP POTENTIAL:

Provide specific examples of how the nominee has demonstrated support for the advancement and leadership development of business and professional women.

This is an essay or narrative portion again. This is again one of the 3 important criteria - support for the advancement and leadership development of professional women.

Try to provide the nominee's philosophy about supporting and encouraging the advancement of women in the workplace and in the community.

Talk about how nominee understands the pressures on women having a professional career and a family. Talk about how she/he directly mentors her/his women employees, supports their advancement and education and professional development, and spends personal time, energy and expertise to encourage growth and success. Talk about how she/he supports the education and advancement of young women and students.

Get a testimonial from an employee or provide your own.
